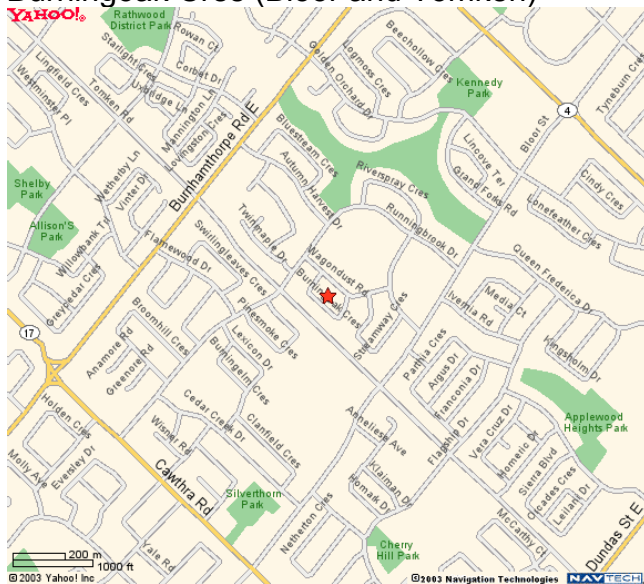
Donna Lenner has set up a voice mail box #31 at the office number. There are flyers available and it's on the CEC website.
